

**MEMORANDUM OF UNDERSTANDING
BETWEEN
ALVORD UNIFIED SCHOOL DISTRICT and
CALIFORNIA SCHOOL EMPLOYEES ASSOCIATION and its
ALVORD CHAPTER 339**

**Pizza Hut
May 19, 2023**

This Memorandum of Understanding is made and entered into effective May 19, 2023, between the Alvord Unified School District (“District”) and the California School Employees Association and its Chapter 339 (“Association”)(hereafter collectively referred to as the “Parties”).

RECITALS

During the past four years the District and CSEA have worked together to increase participation in the school lunch program and to create more options for Alvord students while maintaining quality classified jobs for the Alvord community. One of those options has been utilizing a pizza vendor to provide a brand name pizza product which Alvord students enjoy.

The Parties agree as follows:

1. The Parties agree that Child Nutrition Services (CNS) will use Pizza Hut as a vendor to provide one commercially prepared food item for Alvord Unified School District’s School student lunches.
 - a. The District agrees such commercially prepared food will have no impact on CNS classified bargaining unit staffing levels.
2. Beginning with the 2023-2024 school year, the District agrees to provide CSEA with student lunch participation data disaggregated by school day by no later than May 1, 2024.
3. The Parties agree that the terms of this MOU are not precedent setting.
4. The Parties agree that either the District or the Association may withdraw their agreement with this MOU provided that notice is provided on or before June 1st for the subsequent school year.

This MOU is subject to all approvals required under CSEA policy 610 and AUSD Governing Board.




