The Special Meeting of the Board of Education of the Alvord Unified School District was called to order at 6:01 p.m. by President Kaspereen, in the Board Room of the District Office.

Hearing Session: President Kaspereen extended an invitation to the audience to present matters of concern related to Closed Session items.

- Scott Andrews expressed concerns regarding an editorial in the Press Enterprise that attacked the Board and questioned their ability to run the District. The person who wrote it does not live in the District nor have children who attend our schools. He has no real sense of our history. Scott is impressed with the progress the Board has made on working together and acknowledged the hard work the Board President has done to make this happen. He thanked the Board members for tuning out all the public vitriol and doing their jobs. Scott stated that he is asking politely that the neighbors to the east mind their own business and take care of their own issues and allow us to take care of ours.

4. CONDUCT PUBLIC HEARING - Public Disclosure of the Memorandum of Understanding between Alvord Unified School District and the California School Employees Association and its Alvord Chapter 339: California school districts are required to disclose the fiscal impact of any negotiated agreement, and conduct a public hearing so that members of the public may be given the opportunity to provide input prior to ratification by the Board.
 - Scott Andrews expressed concerns over the current financial state of the District and expressed the need to find ways to tighten our belts. He believes we need to do what the City of Riverside has done and begin the process of negotiating with our Unions to eventually have them pay at least a part of their medical and all their retirement benefits. He urges the Board to start the conversation now. He stated he has a problem with asking the tax payers to pay for health benefits for those who chose to retire early before they can receive Medicare, as it is a person choice. The private sector does not have that choice; they pay for their own medical until Medicare kicks in.

5.
