The Regular Meeting of the Board of Education of the Alvord Unified School District was called to order at 5:00 p.m. by President Kaspereen, in the Board Room of the District Office.

A quorum was established with the following Board Members in attendance:

<u>Hearing Session:</u> President Kaspereen extended an invitation to the audience to present matters of concern related to Closed Session items.

- ➤ Reynalda Bodnar Mrs. Bodnar addressed concerns regarding staff not being notified regarding rumors of a student on campus with a gun. She stated the principal did not follow protocol and needs to be held accountable.
- ➤ Coleen Nagel-Herring Mrs. Nagel-Herring came forward and stated teachers deserve to be paid the salary they deserve and to be respected. She is a product of Alvord and came back because she loves this district. Mrs. Nagel-Herring stated she has appreciated the vision of Dr. Salazar that students are first and teachers behind them.
- ➤ Mike Kolonics Mr. Kolonics spoke on his concerns regarding the changes in the District since last December. He stated that the association, the management and the Board were getting along just fine before December. Mr. Kolonics stated last year the association respected the concerns of the Board and did not request a salary increase even though other surrounding districts did. He stated the teachers deserve respect and requested that the Board to do the right thing.
- Orquidea Wilcox Ms. Wilcox stated she was concerned that four adults were not doing the right thing. Ms. Wilcox asked what has changed. She encouraged them to think really hard and demonstrate that they are here for the teachers, students and the district.



- ➤ Penny Escalante Ms. Escalante stated that she recognized the job of the Board is not easy. Ms. Escalante said she is very blessed to work in a school where teachers collaborate even after their contract hours, blessed to have leadership of Mrs. Vaughan because she encourages them to do their best and blessed to have a Superintendent who believes in our children. She thanked Dr. Salazar for allowing her to spread her wings as an educator and said she hopes he is around to see her through her retirement.
- ➤ Doris Gale Ms. Gale stated Mr. Barragan was legally elected to his position on the Board, similar to Mrs. Wilson. She stated the Board cannot answer to items spoken to on the podium. Ms. Gale said Mr. Barragan was found innocent of any allegations.
- ➤ Allison Barron-Maciel Mrs. Barron-Maciel provided the Board with what a typical day is like for her as a teacher. She stated teachers need to be compensated fairly. Mrs. Barron-Maciel stated the district needs to remain competitive in regards to salary in order to recruit the best teachers.

The Board adjourned to Closed Session at 5:26 p.m. and reconvened to Open Session at 7:05 p.m. in the Board Room of the District Office.

- 4. <u>Ward 6 Update:</u> Councilman Jim Perry provided an update on recent activities and accomplishments taking place in Ward 6.
 - Councilman Perry stated that Raising Caine's Chicken Finger restaurant opened on Tuesday and we are very fortunate they chose this neighborhood to open their only restaurant located in Riverside. He stated they are working hard to be involved in the community. Councilman Perry announced next Thursday there will be a community meeting at La Sierra High School regarding potential electricity rate increases and encouraged everyone who lives in the city of Riverside to attend and voice their opinion. He was happy to announce that they have struck a couple of deals with the Riverside Police Association. The Association will go to Wells to measure students' feet to provide shoes hopefully by Christmas time to students and they are teaming up to do a toy drive on December 2 at Zacatecas Restaurant to collect toys for children in two

neighborhoods one in Eastside and one in Arlanza. He stated lastly, they will be doing the Second Annual La Posada event at 4:30 p.m. at Bryant Park.

<u>Student Representatives:</u> Libie Duenas, Alvord Alternative Education; Alex Phillips; Alvord High School; Irina Badescu, Hillcrest High School; Justice Avedano, La Sierra High School; Brianna Pearce, Norte Vista High; reported on current activities at their respective school sites.

- c. <u>Classified Employee of the Month</u>: Daniel Gonzalez-Reta was selected to represent Norte Vista High School as the Alvord Unified School District Classified Employee of the Month for November 2017.

<u>Hearing Session:</u> President Kaspereen extended an invitation to the audience to present matters of concern to the Board. The following individuals came forward:

- ➤ Debbie Mitchell Mrs. Mitchell provided shirts to the Board of Education for the Alvord Cares Walkathon on Saturday and invited them to attend.
- Reynalda Bodnar Mrs. Bodnar stated that there have been two incidents of students bringing a gun on campus at La Sierra High School and the staff was not notified. She stated she was upset that her husband was endangered due to the principal not following protocol. Mrs. Bodnar is asking Board of Education to conduct an investigation.
- ➤ Eric Vargas Mr. Vargas stated he was concerned regarding his son's assignment from Arizona Middle School on the Five Pillars of Islam. He said he felt that it was shocking to him regarding the amount of time focusing on this religion in comparison to other religions in the history textbook. Mr. Vargas stated he wanted to bring it to the Board's attention.
- ➤ Mike Kolonics Mr. Kolonics provided history to the Board regarding the previous fiscal crisis eight years ago. He stated the district laid teachers off, gave salary cuts and issued furlough days. He said the association was against it so they protested like today and at the end of that year the district ended with 8x the amount required for the reserve.

- Mr. Kolonics stated teachers got their jobs back after they had lost their homes all due to the three-year multi-projection.
- ➤ Louie Magallon Mr. Magallon stated he couldn't understand why students are being taught about a religion of hate. He was concerned on the influence this would have on young students given all the issues occurring in the country. He said we should instead focus on teaching students industrial arts to help them in the future. Mr. Magallon was concerned that not all students will attend college and the lack of industrial arts programs to assist those students.

Board/Superintendent Comments:

Joseph Barragan ~ Mr. Barragan stated he thinks it's important that the public know what the strategy of AEA is - let's get more nasty. He said he wasn't here years ago but still has contact with past Board members. Mr. Barragan stated they will stoop to the lowest of the low for being educators who preach to our children. He said he knows that not all teachers are like this but this is supposed to be the cream of the crop leadership and when they didn't get their way they targeted Board member's homes and left dog (expletive) in mail boxes.
