Lori Kizer from Lake Hills Elementary School, Judy Kennedy from Terrace Elementary School and Ian Fish from Norte Vista High School were selected to represent Alvord Unified School District as the District Teachers of the Year for 2018.

<u>Hearing Session:</u> President Kaspereen extended an invitation to the audience to present matters of concern to the Board. The following individuals came forward:

- Leigh Hawkinson submitted proof that Mr. Barragan made additional charges to his room in the amount of \$337.09. Ms. Hawkinson stated that through a Public Record Request she found out that Mr. Barragan is trying to negotiate the sale of district property. Ms. Hawkinson stated she has copies of surrounding districts salary schedules for teachers and we are not the highest paid in the nation. Ms. Hawkinson is disappointed in the silence of the Board. Ms. Hawkinson commented that confidential information is being released to non-Board members. Ms. Hawkinson stated that the Board will be hearing from her and hundred others if Dr. Salazar is gone, as the collaboration between the Superintendent and AEA is unlike any in the state as evident by the recognition from NEA. Ms. Hawkinson stated that if the Board can't see its way from its own agendas and intentions to do what needs to be done; then maybe a recall of all Board Members is necessary.
- ➤ Pye Cornejo read an excerpt from an article published in 2011 regarding "The High Cost of Low Teacher Salaries." A world class education cost money. Ms. Cornejo cannot press upon Mr. Barragan the sacrifices made by teachers. Ms. Cornejo stated that you cannot believe everything you hear and read. Consider your sources before you cast disparages on the teachers in this district.

- ➤ Gaby Plascencia who represents the Committee to Recall Mr. Barragan,
- ➤ expressed to Mr. Barragan that you can post or give interviews stating that the recall paperwork you were served is wrong but your recall is coming. Ms. Plascencia stated that Mr. Barragan publically supports discriminatory policies and attacks on public education. Ms. Plascencia stated that it is a disgrace the way Mr. Barragan takes pictures with teachers knowing that he bashes teachers publically. Ms. Plascencia stated that Mr. Barragan is making the committee's job easier by the way he violates Board Policy.
- Susan Bain a teacher indicated she has attended the past few meetings and has heard that teachers are being political; we are not being political just defending our jobs. Ms. Bain read a letter titled "Education is not a commodity" from a former student, Angel Lopez, who is now a Stanford Student who writes how Alvord teachers had a positive influence on his education.
- Elsa Barboza, CSEA President, addressed agenda item 15 the reduction of hours for a Classified Instructional Computer Assistant at Terrace Elementary due to lack of work. Ms. Barboza asks that the Board reconsider this as the Governor's Revision shows an increase in funding to school districts.
- Collette Lee, concerned citizen of Riverside, stated she has seen great strides happening in this district. Ms. Lee indicated that what is happening with one Board member is cancer and in her opinion Board members need to function as a team and support teachers, principals, students and the Superintendent. Ms. Lee expressed her concern regarding the dissent between employees and Board members. Ms. Lee stated that Dr. Salazar's sole mission is to make sure students achieve. Ms. Lee requests that the Board take their responsibility serious and make decisive decisions so the school district can move forward.
- ➤ David Bluestein, teacher, stated he has been a teacher for over half of his life and does not like how Mr. Barragan labels him as a "what" and not a "who". Mr. Bluestein stated that you don't know any of us you criticize; my suggestion to Mr. Barragan is that you look at the better angels of your nature before your make comments.
