**Hearing Session:** President Kaspereen extended an invitation to the audience to present matters of concern to the Board. The following individuals came forward:

- Ben Clymer Jr. citizen and small business owner stated he has been a mentor for the La Sierra Business Academy for the past 4 years and has seen how impactful this program is and what little fiscal impact there is because of volunteers. Mr. Clymer stated that one Board Member is passionate about Life 101 and Mr. Clymer would like to mold Life 101 after the Business Academy. Life 101 would teach our students life skills like home economics, job interviews and how to look people in the eye. Mr. Clymer pointed out a saying on a shirt that says “Be the Difference”. Mr. Clymer stated that being the difference is important as citizens and residents. Mr. Clymer offered 20 full scholarships to juniors and seniors; students must write an essay on what it means to them to be part of a community and why civic engagement is important.
- Pye Cornejo, Ms. Cornejo expressed thoughts about her life and the life of her children and how her children made the best of their education. Ms. Cornejo is offended to hear she is overpaid, should make less money and then borrow money for a vacation. Ms. Cornejo is surprised when she looks at photos of students receiving awards and there are four smiling Board Members beaming with pride and then she sees another Board member not smiling, not a trace of pride on his face, you can clearly see that he doesn’t care about the success of our students in Alvord.
- Gabriela Plascencia, Representative for the recall of Joseph Barragan. Ms. Plascencia stated that the committee has not forgotten and they are following through with their promise, and that is evident by the fact that Mr. Barragan was served recall papers tonight. Ms. Plascencia indicated that Mr. Barragan’s days are numbered and it is clear by the lack of support he has received. Our community deserves a Board with high integrity and a high level of human decency, not a racist. Ms. Plascencia urged the community not to forget the awful comments Mr. Barragan made during a radio interview.

- Raymond Shipley read the following statement: Hello, my name is Raymond Shipley, and I have two children in the school district. I have only 3 minutes, so I suppose I'd better dive right in. For too long now this district has been plagued by a cancerous presence by the name of Joseph J. Barragan. From hateful social media posts to claims of criminal fraud, conspiracy and obstruction, it is an outrage that rather than remove or censure the rabble-rouser this Board has chosen to censure themselves. Whether this has been done out of cowardice or collusion I do not know. This Board has heard so many complaints about this person already; I have decided to take a different approach. The feelings of this community have been clear and stated, as has the decision to disregard said feelings by Mr. Barragan. Clearly the will of the People matters not in this case. So, perhaps the facts will be more compelling. As conservative writer and editor Ben Shapiro is fond of saying, "Facts don't care about your feelings." Mr. Barragan has, for some time now, been in clear violation of a multitude of Board Policies regarding his actions and accusations. Specifically, BP 1100 Communication with the Public and BP 9010 Public Statements, which reference the need for a consistent, unified message: "The Superintendent or designee shall provide the Board and staff with communications protocols and procedures to assist the district in presenting a consistent, unified message on district issues. Such protocols and procedures may include, but are not limited to, identification of the spokesperson(s) authorized to speak to the media on behalf of the district." BP 1100 "The Board of Education recognizes the responsibility of Board members in their role as community leaders to participate in public discourse on matters of civic or community interest, including those involving the District, and their right to freely express their personal views. However, to ensure communication of a consistent, unified message regarding District issues, Board members are expected to respect the authority of the Board to choose its representatives to communicate its position and to abide by established protocols." BP 9010 "When speaking to community groups, members of the public, or the media, other individual Board members should recognize that their statements may be perceived as reflecting the views and positions of the Board." BP 9010 "The Board encourages members who participate on social networking sites, blogs or other discussion or informational sites to conduct themselves in a respectful, courteous and professional manner and to model good behavior for District students and the community. Such electronic communications are subject to the same standards and protocols established for other forms of communication." BP 9010 BP 1112(a) Media Relations, which states only the Board President, Superintendent and public information officer are authorized to speak to the media: "Spokespersons designated to speak to the media on behalf of the District include the Board President, Superintendent and public information officer. Other Board members and staff may be asked by the

Superintendent or designee to speak to the media on a case-by-case basis." BP 1112(a) BP 9000 Role of the Board which states the need for a common vision for the district and that the Board shall "hire and support the Superintendent.": "The Board shall...Involve the community, parents/guardians, students and staff in developing a common vision for the District focused on learning and achievement and responsive to the needs of all students...(and) Hire and support the Superintendent so that the vision, goals and policies of the District can be implemented." BP 9000 In other words, Mr. Barragan is not authorized to communicate with the media, including "social media," as he has not been designated to do so. Moreover, Mr. Barragan is likewise in violation of the policies which demand a "consistent, unified message," "common vision" and "support (for) the Superintendent". I'm sure the claim will be made these statements, accusations and pot-shots have all been done as a "private citizen" and not as a representative of this Board. But even a child would recognize this farce, as Mr. Barragan routinely advertises his Trustee position in an illogical attempt at "argument from authority" to mask his other "ad hominem", "straw man", etc. non-arguments. He uses a misguided First Amendment claim as his personal "safe space" to wantonly cause disruption and chaos. He has clearly forgotten BP 9200(a) which states very clearly: "Board members shall hold the education of students above any partisan principle, group interest, or personal interest." BP 9200(a) Mr. Barragan is responsible for 3 schools and yet his focus has been on that which he does not understand and over which he has no authority. Moreover, his conduct not only violates Board Policy, it shames the entire community and district in its juvenile and misguided nature. By any objectionable unit of measure he is an absolute failure as a member of this school board. Mr. Barragan, you are fake news. You are wasting valuable district resources conducting a witch-hunt and have nothing to show for it. You are also in violation of Libel Laws against my wife, and I will be filing a Libel suit against you if you do not cease immediately. Libel is a false and unprivileged publication by writing, printing, picture, effigy, or other fixed representation to the eye, which exposes any person to hatred, contempt, ridicule, or obloquy, or which causes him to be shunned or avoided, or which has a tendency to injure him in his occupation. Ca. Civ. Code § 45 Lastly, since the District was recently audited and passed the audit with no findings of wrongdoing, I call upon the Board to take care of the issue of Mr. Barragan via either his removal or censure. And, by the way, Education Code 35160 states, in part: "The Board is authorized to establish and finance any program or activity that is not in conflict with, inconsistent with, or preempted by law." Ed. Code 35160. No more tantrums, no more libel, and no more fake news.

- Leigh Hawkinson, President of AEA, stated that it is her understanding that Mr. Barragan has not reimbursed the District for the \$300.00 room upgrade or the \$9.00 bottle of water that he charged to his room. Ms.

Hawkinson would like follow-up on that matter. Ms. Hawkinson stated that AEA will be awarding \$8000.00 worth of scholarships to 24 high school students at the senior award nights. Ms. Hawkinson indicated that AEA will be recognized for their Professional Development Program and the corporation between the association and the district. The National Education Association will recognize AEA as a national model on May 22<sup>nd</sup>. Ms. Hawkinson will keep everyone informed of the details. Ms. Hawkinson thanked Jennifer Schriver, Jackie Casillas, Julie Koehler-Mount and Angela Gallardo-Hopkins for all of their support and especially Dr. Salazar for the vision to allow this to happen and to help our teachers.

- Elsa Barboza, President of CSEA, stated that the association is concerned about the direction of the Child Nutrition Department. Ms. Barboza indicated that as positions become vacant they are not filled or subbed which gives the impression that CNS is slowing being done away with. Ms. Barboza stated she has visited school sites and observed workers working harder and faster with less man power which will not be a cost saver because worker comp claims will go up. Ms. Barboza stated at the last Board meeting there was mention of students going hungry that should be a red flag that CNS is one of the most vital departments in the district. Ms. Barboza has noticed increased spending for outside vendors to provide services which our district already has. Ms. Barboza would like the District to work collaborative with CNS to build trust and transparency.
- Penny Mayor, Ms. Mayor stated that she is saddened by the political arena that the teachers have chosen to take. Ms. Mayor stated that it has come to her attention that kids hate the school food and schools are not welcoming. Ms. Mayor stated she wished everyone could get along. Ms. Mayor is concerned about property being sold and doesn't want that to happen.
- Karina Ambriz, community member, stated she signed the recall for Mr. Barragan because of his hateful views which have no place in this amazing district. Ms. Ambriz stated that Mr. Barragan has denied these actions, but she knows them to be true because she has heard them while attending the same high school. Ms. Ambriz stated he does not represent our community or students the way he should and she worries that he will destroy our district. Ms. Ambriz stated that Mr. Barragan has brought fear to parents and students.

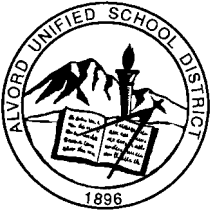
